Members from Nexus Planning presented the planning overview of the proposed SEND school which would support children with special needs. The school would support 65 students with social, emotional, and mental health issues (SEMH), aged 4 - 16, from the immediate and surrounding areas. The new school will comprise a 2 storey teaching block (circa 2,094 sq.m) with associated car parking, hard play, soft informal landscape, all weather five-a-side pitch

The application has been based on key planning considerations, i;e with the school building being proposed on the right hand side of the site due to sewer and water mains on the left hand side of the site. it is proposed that the site entrance is positioned further down the lane and the

overhead power cables will be buried under ground.

The Chair thanked the team for their presentation and asked members if they had any further questions.

A member enquired about what percentage of labour and materials would be local?

The developer (Kier) will endeavour to use local labour and materials if possible and a "meet the buyer event" will be arranged to engage with local organisations.

A question was asked about the estimated cost of the build, but this could not be answered at this stage and would not be available until the project is completed

A member enquired about the road network and the fact that Turfdown Road is nothing more than a lane which gets extremely busy when the crematorium is in use. She was concerned that with increased number

of vehicles that could be needed to transport the 65 students plus staff.

A travel plan has been prepared to promote sustainable travel usage for staff, pupils and visitors and the new access way had been designed to accommodate any queuing traffic and is off set against the junction to the land and is not opposite to the crematorium.

Over time it is hoped that the school would be able to open up the facilities both internally and externally for use by the local community.

Cllr P Rogerson, who sits on the Children and Families Overview and Scrutiny Committee for Cornwall Council spoke in favour of the much needed, proposed new SEND in Bodmin and urged the committee to support the proposals.

Cllr J Gibbs arrived at 18.30.

Members agreed that they wished to amend the resolve made in November 2022 as they now feel issues they raised previously have now been explained and reduced in scale..

In November 2022 BTC Planning Committee reached the following resolve under P.2022.309 PA22/09009:

"It was **RESOLVED** Whilst Bodmin Town Council do support a school being built, but not necessarily in that area. It was proposed that the application not be supported under ground of size, scale and character per Section 124 of the National Planning Framework":

In accordance with Standing Orders 7 Previous Resolutions

a) A resolution shall not be reversed within six months except by a special motion, which requires written notice by at least nine councillors to be given to the Proper Officer in accordance with standing order 9.
b) When a motion moved pursuant to standing order 7 (a) has been disposed of no similar motion may be moved for a further six months.

The Chair proposed to rescind the original decision made in November 2022 and to bring the original motion back to the next planning committee on the 29th March with a written notice by at least nine councillors in support of the application for a new SEND school in Bodmin.
